Meetings

The full Governing Body meets at least once per term to perform its duties as outlined in the Governance Policy. It meets additionally each term for training sessions or as required.

There are specific <u>Agendas</u> for each of the termly meetings in line with the needs of the school year. These can also be found in the Governance Policy.

Committees

There are three main Committees which meet at least termly to cover different aspects of the school operations. These are:

- Curriculum, SEND and Safeguarding
- Finance, Audit and Estate
- Parental & Community Liaison, Nursery and Fundraising (1).
- (1) Note that this Committee also provides input and support to the Charity Trust meeting for accountabilities relating to the Nursery, building and fundraising
- A Performance Management & Governance Committee meets as required and at least once per year to review the performance of the Head and staff team and progress against the school's objectives.

There is also an adhoc Operating Committee which is called upon to support the Head and the management team as required with operation matters and considerations.

Key Focus Areas This Year

The key areas of focus of the Governing Body this year are:

- To understand the approaches to assessment and evaluation of progress of individual children and cohorts
- To support the staff in reinforcing the learning behaviours of pupils

- To support the piloting and implementation of wrap-around care provision
- To undertake Trustee training and reinforce the Trustee body with new members
- To reinforce the marketing of the school to attract prospective parents
- To ensure the ongoing financial sustainability of the school
- To support the Head and staff in preparation for a future OFSTED inspection.
